CONDITIONS FOR ADMISSION

1. The applicant and his parents should be basically from Parakala Math Srivaishnava or any other Srivaishnava Mathams community. Preference will be given to Parakala Math community students.
2. Preference will be given to Students belonging to Sri Vaishnava community over other Brahmin Communities
3. Admission to other Brahmin Sects like Smarthas and Madhvas shall be given if no application(s) from Srivaishnava community is pending
4. In the case of Non Sri Vaishnava Community certificate from their respective Mathams / or two prominent persons acceptable to the Sabha MUST be produced before admission. It should accompany this application.
5. The student and his parent together will be interviewed on a fixed date as decided by the Sabha before admission
6. The Sabha reserves its right to admit or reject any application. The decision of the Sabha in this regard shall be final and no disputes on this matter will be entertained.
7. The Sabha shall fix monthly maintenance fee to be recovered from each student from time to time depending upon the recurring cost of amenities provided. The Sabha reserves its right to alter/change/increase the monthly maintenance fee at its discretion.

8. Each student shall deposit a sum of Rs 5,000 that shall be refunded to the student on his vacating the Hostel. However the amount shall be forfeited in case of any damage to the facilities provided. The Manager/ Warden shall be deciding authority regarding the cost of damages and amount of recovery to be made.
9. Admission shall be permitted after all formalities are completed and payment of the Caution Deposit and monthly maintenance fee is paid.
10. The Sabha reserves its rights to eject or disallow an admitted student into the Hostel in case he fails to remit the maintenance fee to the Hostel Manager before 10th of each month. No separate notice will be given to each student in this regard.

CERTIFICATE

**CONDUCT RULES AND REGULATIONS FOR STUDENTS IN
HAYAGREEVA MANDIRA VIDYARTHI NILAYA, MYSORE**

1. Students who have secured admission into full time courses of PUC/ diploma/ Degree/ Post Degree in recognised institutions in and around Mysore shall be eligible for admission to the Hostel as boarders.
2. The admission is for one academic year only. In case of Semester system the final semester of the course shall be treated as the conclusion of the academic year. In case of renewal of the admission the student should inform the Sabha in advance at the time of admission.
3. The Sabha shall charge a sum of Rs 1,000 per month per student and may revise the same from time to time. Each student is required to pay a Caution deposit of Rs 5,000 that will be refunded at the time of vacating the Hostel subject to conditions like no breakages / damage of facilities etc.
4. In case a student vacates the Hostel before the conclusion of the academic year he shall clear not only the entire dues up to date to the Sabha but also pay the rest of the maintenance fee for the entire academic year as determined by the Sabha.
5. The Hostel is primarily for Srivaishnava Parakala Math community and to followers of other Sri Vaishnava Mathams. However, the Sabha may also admit other sub sects of Brahmin community in case of availability of accommodation. The non Sri Vaishnava Brahmin students may be charged a maintenance fee as determined by the E C of the Sabha..

6. All students shall behave in a disciplined manner and shall follow all lawful instructions given by the Manager / Warden
7. All students admitted shall carry their Photo ID on their person or produce the same on demand by Sabha authorities. In case of loss of ID the cost will be recovered from the student before a new ID is issued.
8. Rooms shall be allotted on first come first served basis depending upon the admission strength for that academic year. Students may change the rooms / beds with mutual consent only with the consent of the Manager / Warden who shall make proper allotment changes.
9. All students should vacate their beds latest by 7.00 a.m. All boarders should assemble for morning and evening prayers if arranged for by the Manager / Warden
10. Student inmates shall keep their Rooms / Beds clean and not to scatter their belongings. One student per room shall be responsible for the cleanliness of that room.
11. Students shall secure their belongings and keep it safe. The Sabha will not be responsible for any loss of cash or valuables like mobile phones / computers etc.
12. The toilets should be kept clean and properly flushed. The bathrooms should be used properly without damage to the sanitary fittings. Taps should be closed properly so that water is not wasted. In case it is found to be damaged or irreparable the cost shall be recovered from the concerned student
13. Students shall not waste water or electricity. All electrical appliances should be switched off when not in use.
14. All students shall return to the Hostel before 9.00 p.m. The Warden shall reserve his right not to allow the student into the Hostel after that time in case valid reasons are not given.
15. In case any student wishes to stay away for the night or come late, advance permission in writing should be obtained from the Manager / Warden. In case any student stays away without permission he shall be subject to disciplinary action including removal from Hostel, if necessary.
16. The rooms are exclusively meant for the students admitted. Students SHALL NOT permit any of their relatives / friends into the rooms. They are required to meet them in the office room only.
17. Students are PROHIBITED from Smoking / Drinking alcohol / Drug abuse / Playing cards / Stealing and indulge in avoidable political discourse. In case any student is found indulging in any such activity, he shall be immediately expelled from the Hostel after informing the parent and the Sabha shall also forfeit the deposit given by the Student at the time of admission.
18. A disciplinary committee among the students may be set up along with the Warden to oversee the activities of the Students, Maintenance etc. The leader shall be selected by rotation.
19. Any issue relating to health and illness should be reported to the Warden Manager immediately so that remedial action is taken and medical attention is given.
20. The rules are framed by the Sabha keeping the interests of the Sabha and students in general. Sabha reserves its rights, if circumstances so warrant, to withdraw / alter / include any regulations it deems fit depending on the requirement and to protect the interests of the Sabha and the Hostel in particular.

All students and their parents are bound by the above said Rules / Regulations / Conditions. Any Student or Parent having any objection to any of the aforesaid may not be admitted to the Hostel. The decision of the Sabha in this regard shall be final.
